

South Island Open Series

Rules

- * All exhibitors, handlers or parents must follow posted COVID regulations as set out by the Province of British Columbia and/or Show Management
- * Exhibitor's age is as of January 1, 2022
- * All Exhibitors must present proof of current 2022 Horse Council of British Columbia (HCBC) Numbers. No Exceptions
- * Show Management reserves the right to deny any person(s) participation in any event hosted by the South Island Open Series/Creekside Equestrian Ltd at their discretion.
- * Inhumane treatment of horses will be grounds for disqualification, as well as abusive treatment of show officials and fellow competitors
- * All classes will be judged according to the Equestrian Canada General Performance Rules
- * Proper Show Attire for both English and Western classes are to be worn in the Show Pen
- * Proper Riding Attire for both English and Western are to be worn while riding on the grounds
- * English Riders must wear a approved Helmet when mounted
- * Western Riders are recommended to wear a Helmet. Cowboy Hat is permitted
- * Riders showing in Western classes, may ride in a Snaffle Bit two handed regardless of the horses age. If riding in a Shank Bit, riders are required to ride with 1 Hand.
- * English Riding attire must consist of a show shirt, show jacket, breeches, proper boots with a heel, and a helmet
- * Western Riding attire must consist of a long shirt with a collar, jeans, proper boots with a heel, and a helmet or cowboy hat
- * Training Equipment is NOT permitted in the show arena.
- * All tack must be in working order
- * Numbers to be displayed on the Exhibitors back or on the saddle pad. If displayed on the saddle pad, Exhibitors are required to have 2 numbers (Second number provided by Exhibitor)
- * Cash, Cheque or E-Transfer accepted. E-Transfer can be sent to southislandopenseries@gmail.com , Cheques can be made out to Creekside Equestrian Ltd
- * There will be a \$50 fee for any 'NSF' Cheques
- * Show Management has the right to combine classes if insufficient entries occur
- * Exhibitors are not permitted to engage in conversation with the Judge unless given permission by the Show Management
- * To be eligible for Series High-Points, the same Horse & Rider combination must ride at all 4 shows
- * Professional riders/trainers are not permitted in any age specific category
- * 13 & Under: Open to any youth 13 yrs of age or younger as of January 1st
- * 14 - 18: Open to any youth 14-18 years of age as of January 1st
- * SR: Open to any rider 19 years of age or older as of January 1st
- * 1st Year Horse/Rider: 1st Year of showing for either the horse or rider. No X-Entry in any other division
- * Walk Trot/Jog: Open to any riders/horses. No X-Entry in any other division
- * Pony 14.2hh or Under: Ponies 14.2hh or Under
- * Open: Open to any rider/horse combination

Leadline Rules :

- *Ages 12yrs and Under
- * Rider must be led at all times with a halter and lead rope. The halter can be over or under the Bridle
- * Full Tack is required
- * The rider must have their feet in the stirrups
- * The rider should be wearing proper riding attire
- * Riders can show English or Western
- * Riders will be required to walk in a large circle using 1/2 the show pen and change direction
- * Colour, Bling, Sparkles, Etc is encouraged but not required
- * Admin fee is waived for the Leadline class

Waiver

I hereby release the South Island Open Series & Creekside Equestrian Ltd and their volunteers or representatives, from any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show management blameless of any loss or accident to his/her horse or horse's equipment, any accident or injury that may happen to the rider/handler of any horse during this event.
